Several Policies of Beijing Economic-Technological Development Area (BDA) on Supporting High-quality Development of Foreign-invested Enterprises

To implement the spirit of the relevant documents of the State Council and Beijing Municipality on further optimizing foreign investment environment and increasing intensity of attracting foreign investment, comprehensively upgrading efficiency of Beijing E-Town to promote the high-quality development of foreign-invested enterprises, promote a new round of high-level opening-up, this policy is hereby formulated as following.

Article 1. Support the establishment of headquarters-type enterprises of multinational companies.

Foreign investors who newly establish regional headquarters or functional headquarters of multinational companies in E-Town Free Trade Zone, will be granted establishment incentives of no more than 3 million yuan or 2 million yuan respectively, paid in 3 years at rates of 40%, 30%,

The above-mentioned enterprises, if the total paid-in contract foreign capital is equal to or more than 10 million US dollars within one year from the date of establishment, will be rewarded 2.5% of the total paid-in contract foreign capital, no more than 30 million yuan for each enterprise. Among them, for the regional headquarters and functional headquarters of the world's top 500 multinational companies (according to the annual ranking of the American economic magazine "Fortune" in the past five years), the reward ratio can be increased by 0.5%, and the maximum reward is 100 million yuan.

Article 2. Support the development of foreign-invested enterprises in the field of advanced manufacturing. Foreign-invested enterprises newly established by foreign investors in the fields of advanced manufacturing that conform to the industrial development direction of E-Town, if their total paid-in contract foreign capital within one year from the date of establishment is 10 million U.S.

of paid-in contract foreign capital as reward, up to 30 million yuan for each enterprise.

To support the large-scale development of foreign-invested enterprises in advanced manufacturing fields such as new-generation information technology, pharmaceutical and healthcare, new energy intelligent vehicles, and intelligent manufacturing, foreign-invested enterprises newly established during the policy implementation period that break annual output value of 100 million, 300 million, 500 yuan, or 1 billion yuan for the first time, will receive a one-time rewards of 1 million, 3 million, 5 million, or 10 million yuan respectively.

dollars (or the same value in other foreign currency) or more, will receive 2.5% of the total amount

Article 3. Support foreign-invested enterprises to participate in the construction of international service

environment. To support moving in and development of foreign-invested enterprises in E-Town in the service industry (excluding real estate projects), if their total paid-in contract foreign capital within one year from the date of establishment is 2-5 million US dollars, 5-10 million US dollars, 10 million US dollars more, enterprises will receive a one-time rewards of 400,000, 800,000, and 1.5 million yuan respectively.

To support the development of foreign-invested enterprises in production related service fields such as R&D and design, financial services, modern logistics, supply chain management, and information services, foreign-invested enterprises newly established during the policy implementation period that break annual operating income of 100 million or 300 million yuan for the first time, will receive a one-time reward of 1 million yuan or 3 million yuan.

To support the development of foreign-invested enterprises in the fields of law, consulting, medical care, healthcare, elderly care, childcare, tourism, housekeeping and other life services foreigninvested enterprises newly established during the policy implementation period that break annual operating income of 30 million yuan or 50 million yuan, will receive a one-time reward of 500,000 or 1 million yuan respectively.

Article 4. Support the upgrading and expansion of existing foreign-invested enterprises. Foreign investors who make additional investment or increase registered capital using corporate profits, capital reserves, etc. (excluding real estate projects), if their total annual paid-in contract foreign capital is 100 million yuan (or 15 million US dollars) or more, will receive a 1.5% of the total contract foreign capital paid in that year as reward, no more than 20 million yuan for each enterprise.

Article 5. Support the establishment of foreign-invested R&D centers. Foreign-funded R&D centers that are recognized by the municipal industry authorities, will receive 2 million yuan as recognition reward, with a payment schedule of 40%, 30% and 30% in three years.

> Those who are authorized and classified as the global R&D centers of their parent multinational companies, and whose cumulative total R&D investment is no less than 10 million US dollars, and their R&D investments in the previous year account for no less than 10% of their parent company's global R&D investment, will receive an additional 3 million yuan as recognition reward, with a payment schedule of 40%, 30% and 30% in three years.

Article 6. Support the innovation and entrepreneurship of international talents. Foreign-invested enterprises newly established by foreign talents and teams in line with the industrial development direction of E-Town, if their total paid-in contract foreign capital within one year from the date of establishment is no less than 1 million US dollars, and the foreign talents and teams own no less than 30% of company's share, will receive 50% subsidy for office rent for three consecutive years, with the maximum subsidized area not exceeding 2000 m², and the overall subsidy not exceeding 1.5 yuan/ m²/day.

Article 7. Support the construction of internationalized industrial parks. To support the construction of a group of international industrial parks that have the bearing conditions and service capabilities for international enterprises, those industrial parks with clear industrial positioning and in line with the evaluation standards of international parks, will receive facilitation supports such as administrative approval, government services, and opening of supporting resources after recognition.

Those industrial parks who carry out transformation of supporting facilities in office, production, and living conditions according to the needs of internationalized enterprises, and add more than 5 million yuan in related fixed assets (exccluding land purchase costs), will reveive a one-time financial support equivalent to 5% of the fixed asset investment, with maximum no more than 2 million yuan.

Industrial parks that have attracted foreign-invested enterprises (except for enterprises that have already received paid-in contract foreign investment rewards) with a total paid-in contract foreign investment of more than 10 million US dollars (including), (the park operator) will receive financial rewards equivalent to 1% of the total amount of paid-in contract foreign investment, with a maximum of 5 million yuan per year.

Article 8. Strengthen the full life cycle services for the development of foreign-invested enterprises. A

"Two Zones" construction service area is set up to integrate the life cycle of government services for the development of foreign-invested enterprises, and to achieve "one door, one window, and one network" for foreign-related approval matters.

SPECIAL POLICY ON FOREIGN INVESTMENT

Extremely simplified approval services are promoted to create an integrated government administration application scenarios for enterprises focusing on the overall process of contract, construction, and operation of foreign-invested enterprises.

A diversified comprehensive consulting service window is set up to provide enterprises with comprehensive foreign-related consulting services such as international economic and trade rules, certification of origins, and assistance on overseas intellectual property matters.

A green channel for the report and feedback of foreign-invested enterprises is established with a special service hotline for enterprises and an all-weather feedback channel on the online platform, so to provide a "timely and online" butler service.

An inclusive and prudent comprehensive supervision system is explored to establish a credit rating mechanism for foreign-invested enterprises, and to achieve a goal of "least-disturbance" and "active respond" to enterprises.

Article 9. Create a "one-stop" butler service for international talents. Focusing on the actual needs of international talents on entrepreneurship, employment, and entertainment in Beijing E-Town, we integrate services such as senior talent identification, entry-exit visas, etc., and explore and introduce special services called "comprehensive handling of multi-certificates" (work permit + residence permit + medical insurance + social security), improved "one-stop" service capabilities for international talent. Relying on the multi-tentacular platform such as E-Town Enterprise Service Platform, we promote the handling of residence permit, work permit, starting a business, social insurances, and other businesses to further extend to the grassroots such as parks and communities, and explore the "1+N" new service model for overseas high-end talents driven by Beijing E-Town international talent service hall, providing high-quality and diversified "leastdistance" services for international talents nearby.

These measures are applicable to foreign-invested enterprises or institutions that have completed industrial and commercial registration, tax registration, and statistical registration within the area of 225 square kilometers in Beijing E-Town (unless otherwise specified in individual clauses). Foreign-invested enterprises in this policy refer to enterprises invested directly by foreign investors (including Hong Kong, Macao, and Taiwan regions), alone or with other investors. Enterprises need to have no major administrative punishment records and criminal records in the past 3 years, and have not been included in the list of serious illegal and dishonest entities. Enterprises included in the prohibited and restricted categories of the "Catalogue of Prohibited and Restricted New Industries in Beijing" will not be supported.

If the state government, Beijing municipality, and BDA have issued relevant support policies or have implemented the relevant policies of BDA entry agreement (BDA development agreement), it will be implemented in accordance with the principle of "follow higher not lower, follow better and no repeat". Article 1, Paragraph 1, Article 5, Article 6, and Article 7, Paragraph 3 of this policy are not linked to the veconomic development contribution of the year. The total amount of policy support in other clauses shall not exceed 50% of the disposable part of the local-level income of the enterprise in BDA for the year. Key foreign-invested projects are supported in accordance with "special matters, specially managed".

The total paid-in contract foreign capital shall be based on the amount received by the Ministry of Commerce, the amount of policy cashing shall be based on the data fed back by the Ministry of Commerce, and the foreign exchange rate of the country on the actual arrival date of the foreign currency shall be used as the conversion basis.

This policy is valid for three years starting from the date of promulgation. During the implementation period, if relevant parenting policies by state government or Beijing municipality are adjusted, the Policies will be adjusted accordingly.

The Administration Committee of Beijing Economic-Technological Development Area is responsible for the interpretation of this policy.
